Attendance

Actual attendance as of 21.10.2022 is 92.5%. COVID, virus/sickness/holidays have contributed to this, this is slightly lower that the summer term of 93% the target is 96% which we are working towards.

Mrs Mullaney analyses the attendance weekly and produces a comprehensive report which included – year groups/groups and PA (persistent absence). First day calls are made/letters sent out at the appropriate level/lates are recorded (which have an impact on attendance). Families are invited in to speak to the HT and SENDCo – Team Around the Family (TAF) in school to support where needed

Emotional Wellbeing

Wellbeing remains a high priority in school. There are 41 children on the wellbeing register – Mrs McAtominey and myself work primarily from the vulnerability survey from all class teachers - all children on a plan are included. Some children are continuing to show anxieties as a result of the pandemic. Children access either nurture groups/ play therapy or drawing and talking. The impact has been extremely positive. Children affected are settled and are more able to take ownership of their emotions.
